Bond obligating William Hatch, Thomas Nevil and Nathan Caswell to turn over land to the Crown for a road from Little Otter Creek to Spring Creek; "a good and lawful Quitclaim deed of a certain piece of land commencing on the east side Little (Otter) Creek bridge near Nathan Caswell's on Talbot Road in the said Township of Bayham thence up the flats of the said Creek to the mouth of Spring Creek thence to the top of Spring Creek East on Talbot Road." - dated at Bayham, May 6, 1822 - signed by William Hatch, Thomas Nevill and Nathan Caswell - witnessed by John Lodor and Joseph Lodor

"Report of the Alteration of a Road in Vicinity of the Five Stakes leading to Talbot Road East"; Samuel Smith's Report to the Court of Quarter Sessions dated September 28, 1823; recommends that the road should be altered so that it passes through the lands of the late John Mitchell, Hamilton and Warren, and Henry Ramey.

#### **Document 8**

Statement by Isaac Draper certifying that in July of 1825 he assisted Mr. Smith, Land Surveyor, to run the lines between Lots 18 and 19 from the 2nd to the 3rd Concessions in Bayham; mentions the lands of Mr. Midey and Mr. Harris; dated at Bayham, January 11, 1826.

#### **Document 9**

Petition of Stephen Harris and Hezekiah Cartwright of Bayham; to open a road beginning on the Lake Road between Lots 18 & 19 and running north until it intersects the 2nd Concession fronting the 3rd; says that Cartwright and Harris are living on the south half of Lots 18 & 19 in the 2nd Concession; that they are having a great deal of trouble getting out to mills and meetings; Harris has 12 in his family and Cartwright 6; good description of transportation difficulties; petition signed by the following: Stephen Harris, H.
